**Subject: Negotiated procedure pursuant to art. 63, co. 2 lett. b), point n. 3 of Legislative Decree no. 50/2016, aimed at stipulating a contract for IGM ALL for Treasury Department

Request for Proposal**

By means of a determination to contract signed on march 2<sup>nd</sup> 2020, Consip S.p.A. single-member joint stock company (hereinafter also Consip) on behalf of Sogei S.p.A. (hereinafter also Customer), has resolved to entrust the service of IGM ALL.

By means of an Agreement concluded on 12 April 2013, Sogei S.p.A. has entrusted Consip S.p.A. to perform the activities related to the procurement process for the acquisition of goods and services, also including any ancillary and instrumental activities.

The **contract addendum** is attached for the present acquisition.

The supplier has declared, with notice of February 11<sup>th</sup> 2020, that it possesses exclusive rights for the following services/products IGM ALL.

In this Request of Proposals, Consip S.p.A. intends to award the Contract – the subject of which is IGM ALL.

By signing the Contract, the successful company is undertaking to provide the good(s) and/or service(s) referred to above. The Contract will be entered into by Sogei S.p.A.

The Contract will not contain an arbitration clause.

In accordance with art. 31 of Italian Legislative Decree no. 50 of 18 April 2016, Ms Floriana Milisenda is appointed as the person responsible for the procedure.

**Registration on the AVCPass System and use of the National Public Contracts Database (*Banca Dati Nazionale Contratti Pubblici*).**

By virtue of the provisions of par. 13 of art. 216 of Italian Legislative Decree no. 50/2016, until the entry into force of the decree referred to in par. 2 of art. 81 of the aforementioned Italian Legislative Decree no. 50/2016, the contracting authorities and suppliers shall use the AVCPass database kept by the Italian National Anti-Corruption Authority (ANAC).

In view of the above, pending the entry into force of the aforementioned decree, the previous regulations are still applicable: the documentation proving possession of the general, technical/organisational and economic/financial requirements for participating in public calls for tenders must be acquired exclusively through the National Public Works Database (*Banca Dati Nazionale Contratti Pubblici*) (hereinafter, in short, the BDNCP) kept by the National Anti-Corruption Authority (art. 6-bis of Italian Legislative Decree no. 163/2006 as subsequently amended and supplemented, as introduced by paragraph 1a) of art. 20 of Law no. 35 of 04 April 2012). In accordance with the provisions of art. 6-bis of Italian Legislative Decree no. 163/2006 as subsequently amended and supplemented, the AVCP (now ANAC) issued Deliberation no. 111, dated 20 December 2012, which identified, inter alia, *“data concerning participation in tender procedures and the assessment of bids to be inserted into the BDNCP to enable contracting authorities/contracting entities to verify possession of the requirements applicable to suppliers for the awarding of public contracts”*.

Art. 9 of the aforementioned Deliberation, as modified during the formal meetings held on 08 May and 05 June 2013, states that the obligation to perform verifications exclusively through use of the AVCPASS system runs from *“01 January 2014 for contracts with an initial value equal to or greater than EUR 40,000.00”*.

For the purpose of this procurement action, prospective suppliers must register on the AVCPass System according to the operating instructions as well as the terms and technical regulations for the acquisition, updating and consultation of data present on the [www.avcp.it](http://www.avcp.it) website.

Once the economic operator has registered for the AVCPASS service and identified the procedure in which it wishes to participate, it will obtain a **“PassOE” code** which must be inserted into the e-mail containing the documentation requested for participation in the procedure, according to the procedures described below.

In accordance with the provisions of art. 6-bis of Italian Legislative Decree no. 163/2006 as subsequently amended and supplemented, of AVCP (now ANAC) Deliberation no. 111 of 20 December 2012 and of law no. 15 of 27 February 2014, as well as with the provisions of the aforementioned art. 216 (par. 13) Procedure in accordance with art. to art. 63, co. 2 lett. b), point n. 3 of Legislative Decree no. 50/2016, for the purposes of the conclusion of a contract for IGM ALL for Treasury Department.



of Italian Legislative Decree no. 50/2016, Consip shall conduct a compliance check of the requirements relating to this initiative exclusively through the BDNCP.

Lastly, it should be noted that failure to register with the AVCpass service, or to send the PassOE code, will not entail, by itself (unless otherwise stipulated), exclusion from this procedure. By means of a suitable notification, Consip provide suitable deadline for conducting the activities indicated above.>

Sogei reserves the right to negotiate the payment terms with the successful bidder, pursuant to and in accordance with paragraph 4 of art. 4 of Italian Legislative Decree no. 231/02 as subsequently amended and supplemented. This must be taken into consideration when formulating the bid.

The Supplier may not claim any right to other compensations, adjustments or increases of the fees agreed upon in contract, except as provided for by art. 106 of Legislative Decree 50/2016 for recurring and continuous contracts.

In light of the considerations above, the company is therefore required to send to Consip S.p.A., by march 23, 2020 its Bid Declaration, complete with all the documentation indicated hereinafter to the e-mail address: [floriana.milisenda@consip.it](mailto:floriana.milisenda@consip.it).

Please note that, in order to send the documentation indicated hereinafter, which is mandatory in order to participate in the procedure, a certified e-mail address attributable to the supplier has to be used.

In particular, the competing company must insert the following data into the subject line of the e-mail:

***"Initiative no. 366/2019 - Purchase request no. 49726 – attn. Floriana Milisenda"***

The e-mail containing the proposal must include the following:

- a) a **declaration** providing the identification details of the bank account (s) attached (s) to this contract, as well as the general (name and surname) and the Tax Code of the persons delegated to operate on said account (s) in compliance with the provisions of Article 3, paragraph 7 of Law No.136 / 2010 (**Supplier Data sheet and declaration on the traceability of financial flows**).
- b) **The Partecipation Document** to be made pursuant to the D.P. n. 445/2000, containing the attestation of possession of the requirements prescribed by art. 80 of Legislative Decree no. 50/2016 and of any further statements in the facsimile listed in **Annex 1** to this Request for goods/services (the facsimile mentioned may be used for this purpose). This declaration must be submitted as digital document, digitally signed by the legal representative of the supplier, or in any case by a representative with power of attorney.



The declarations concerning the absence of grounds for exclusion referred to paragraph 1 of art. 80 of Italian Legislative Decree no. 50/2016 must be made by the legal representative of the supplier or by a representative with power of attorney vis-à-vis the persons responsible for the duties referred to par. 3 of art. 80 of Italian Legislative Decree no. 50/2016 (i.e. the owner or technical director, if a single-member company. The partners or technical director, if a partnership; a partner and the technical director if it is a company in collective name; of the partners and the technical director, if it is a simple partnership; members of the board of directors who have been assigned legal representation, including general secretaries and prosecutors, members of the bodies with managerial or supervisory powers (i.e. members of the board of statutory auditors in companies with a traditional management system, members of the management control committee in companies with a single management system, members of the board of directors and members of the supervisory board, in companies with a dualistic management system), of subjects with powers of representation, direction or control (such as auditors and the supervisory body referred to in Article 6 of Legislative Decree 231/2001), the technical director and the sole shareholder a natural person, a majority shareholder in the case of companies with fewer than four members, in the case of another type of company or consortium; of persons ceased in the year prior to the date of sending the letter of invitation and in any case until the submission of the bid, if the firm does not demonstrate the complete and effective dissociation from the penalized sanction. The offenses referred to art 80 par. 1 do not apply when they have been de-penalized, when rehabilitation has taken place, when offenses have been declared extinguished after the conviction or in case of revocation of the sentence.

Concerning sole shareholders and majority shareholders in case of companies with less than four partners, please note that both the physical and legal persons are relevant, and the company (together with the auxiliary or subcontractor if any) must thus make the declarations concerning the absence of the exclusion cases referred to in art. 80, paragraphs 1 and 2, of the Legislative Decree no. 50/2016. Concerning legal administrators, the relevant positions are those of the Directors that have representative powers (eg Managing Director, Delegate, Councilor with Representative powers, etc.). It should also be noted that in the case of companies with only two members (whether legal or physical), holding each of fifty percent (50%) of the shareholding, the statements provided for in art. 80 (paragraphs 1 and 2), Legislative Decree no. 50/2016 must be made for both.

It should also be noted that in case of transfer or lease of a business or branch of a business, incorporation or merger in the year before the date of the sending of the letter of invitation and until the date of submission of the bid, the declaration on the absence of the exclusion



criteria referred to art. 80, paragraphs 1, 2 and 5 letter l) of Legislative Decree no. 50/2016, must be made in respect of all the aforementioned subjects who have operated with the transferor / leasing company, incorporated or incorporated companies in the year prior to the date of sending the letter of invitation and until the date of submission of the offer and those who have ceased to be in charge in the same period, which must be considered as "ceased parties" for the supplier.

All the facts referred to art. 80, paragraph 5, of Legislative Decree no. 50/2016 must be declared. In particular, it should be noted that:

- Infringements of the rules on health and safety at work and the obligations under Article 30 (3) (referred to in Article 80 (5) (a)), fall within the scope of derive definitive measures of condemnation against the subjects referred to in art. 80, co. 3, of Legislative Decree no. 50/2016 and so on, for conducts referred to the performance of the functions conferred by the proper economic operator. The assessment of the severity of the conduct carried out by the economic operator is remitted to the contracting station;
- Among the cases referred to in art. 80, paragraph 5, lett. c) of Legislative Decree no. 50/2016 (relevant for the time period referred to in Article 80, paragraph 10, of Legislative Decree 50/2016 and §5), are the those relating to antitrust or other circumstances that may affect the integrity or the competitor's reliability. The supplier, in the indication of the relevant facts shall take into account the indications given in Guidelines no. 6 of the ACN. "Indication of the appropriate means of proof and of the deficiencies in the execution of a previous contract of employment which may be considered significant for the demonstration of the exclusion circumstances referred to art. 80, paragraph 5, lett. c) of the Legislative Decree ".

The operator must declare all the executive measures of the AGCM (the national antitrust authority) condemning unfair commercial practices or unlawful antitrust effects having effects on public contracts and implemented in the same market subject of this procedure. The contracting authority will proceed, in the course of the procedure, to the assessment of the aforesaid provisions of the AGCM if they are unenforceable or if confirmed with the definitive ruling of the administrative judge.

In this case, and in the case of self-cleaning measures, all relevant documents (including any convictions) must be produced in order to allow the Consip to make every reasonable assessment.

**c) Temporary guarantee**

The offer is also accompanied by:

Procedure in accordance with art. to art. 63, co. 2 lett. b), point n. 3 of Legislative Decree no. 50/2016, for the purposes of the conclusion of a contract for IGM ALL for Treasury Department.



- 1) **a temporary guarantee**, as defined by art. 93 of the Code, equal to 2% and precisely of an amount equal to EURO 1.061,88 , except as provided for in art. 93, paragraph 7 of the Code;
- 2) **a declaration of commitment** by a banking or insurance institution or other person referred to in art. 93, paragraph 3 of the Code, also different from the one that issued the temporary guarantee, to issue **definitive surety guarantee** pursuant to Article 93, paragraph 8 of the Code, if the competitor is the custodian. This declaration of commitment is not required of micro, small and medium-sized enterprises and temporary groupings or ordinary consortia exclusively established by them.

Pursuant to art. 93, paragraph 6 of the Code, the provisional guarantee covers the non-signing of the contract, after the award, due to any fact attributable to the assignee or the adoption of interdictive anti-mafia information issued pursuant to articles 84 and 91 of the d. lgs. September 6, 2011, n. 159.

Among other things, the failure to prove possession of the general and special requirements is attributable to the assignee; failure to produce the required and necessary documentation for the conclusion of the contract. Any exclusion from the tender before the award, except for the cases referred to in art. 89 paragraph 1 of the Code, will not lead to the enforcement of the provisional guarantee. The provisional warranty covers, pursuant to art. 89, paragraph 1 of the Code, also false statements made in the context of the availment.

The **temporary guarantee is made up**, at the competitor's choice:

- a. by **Bank Transfer**, with payment made to the Intesa Sanpaolo bank account, using the IBAN (International Bank Account Number) n° IT 38 0 03069 03240 100000005558, Bic BCITITMM, registered to Consip S.p.A., with the following information in the reason for the payment: "Temporary guarantee in the procedure for IGM ALL – CIG 82319167FA – RDA Consip n. 49726".

As confirmation of the payment, the tenderer must send to Consip S.p.A. **a copy of the Bank Transfer receipt in PDF format**, with indication of the IBAN code of the company who made the payment.

It is understood that the tenderer will still have to produce the commitment to issue the definitive guarantee for the execution of the contract, if the competitor is the successful tenderer, mentioned above;

- b. **by bank or insurance guarantee** issued by banking or insurance companies that meet the requirements of art. 93, paragraph 3 of the Code. In any case, the guarantee



guarantees comply with the standard scheme pursuant to art. 103, paragraph 9 of the Code.

In the event of a **bank or insurance guarantee** (point b), this must:

- 1) contain express mention of the object and the guaranteed subject (Consip S.p.a.);
- 2) be registered in the name of all the economic operators of the established / establishing temporary grouping or ordinary consortium or EEIG, or to all the network companies participating in the tender or, in the case of consortia referred to in art. 45, paragraph 2 lett. b) and c) of the Code, to the consortium only;
- 3) comply with the standard scheme approved by decree of the Minister of Economic Development in consultation with the Minister of Infrastructure and Transport and previously agreed with the banks and insurance companies or their representatives and therefore comply with the standard policy schemes of which the Ministry of production activities of 19 January 2018, n. 31;
- 4) be valid for \_\_\_\_ *[almeno 180 gg. - ovvero altro termine, in relazione alla durata prevista per la validità dell'offerta]* days from the deadline for submitting the offer;
- 5) expressly provide:
  - a) the waiver of the benefit of the prior enforcement of the principal debtor pursuant to art. 1944 of the civil code, wishing and intending to remain jointly and severally liable with the debtor;
  - b) the renunciation to object to the expiry of the terms referred to in art. 1957 of the civil code;
  - c) their operation within fifteen days upon simple written request from the contracting authority;
- 6) contain the commitment to issue the definitive guarantee, if issued by the same guarantor;
- 7) be accompanied by the guarantor's commitment to renew the warranty pursuant to art. 93, paragraph 5 of the Code, at the request of the contracting authority for the time necessary to complete the tender operations, in the event that the award has not yet taken place at the time of its expiry;
- 8) report the authenticity of the guarantor's signature; or as an alternative:
- 9) be accompanied by a substitutive declaration of a notary deed of the guarantor certifying the power to bind the surety company with the subscription towards the contracting authority.



The surety guarantee and the declaration of commitment must be signed by a person possessing the powers necessary to commit the guarantor and be produced in one of the following forms:

- IT document, pursuant to art. 1, lett. p) of Legislative Decree 7 March 2005 n. 82, digitally signed by the person in possession of the necessary powers to commit the guarantor;
- computerized copy of analogue document (scan of paper document) according to the methods provided for by art. 22, paragraphs 1 and 2, of Legislative Decree 82/2005. In the latter cases, the conformity of the document with the original must be certified by the public official by affixing a digital signature (art.22, paragraph 1, of Legislative Decree 82/2005) or by a specific declaration of authenticity signed with a digital signature by the notary or public official (art.22, paragraph 2 of Legislative Decree 82/2005);
- electronic duplicate of electronic document pursuant to art. 23 bis of Legislative Decree 82/2005 if produced in compliance with the technical rules referred to in article 71 of the same decree.

In the event of a request for extension of the duration and validity of the offer and the guarantee, the tenderer may produce a new provisional guarantee from another guarantor, replacing the previous one, **provided that it has expressly commenced from the date of submission of the offer.**

The amount of the guarantee and its eventual renewal is reduced according to the measures and methods referred to in art. 93, paragraph 7, of the Code.

To take advantage of these reductions, the tenderer signals and documents the possession of the relevant requirements in the offer by providing a copy of the certificates held.

The non-presentation of the provisional guarantee and / or the commitment to issue a definitive surety guarantee can only be remedied by means of “*soccorso istruttorio*” procedure, provided that they have already been established before the offer is presented. It is the responsibility of the economic operator to demonstrate that these documents are established no later than the deadline for submitting offers. Pursuant to art. 20 of Legislative Decree no. 82/2005, the date and time of formation of the electronic document are opposable to third parties if affixed in accordance with the technical rules on validation (e.g. time stamp).





It is also possible to remedy the presentation of a guarantee of a lower value or without one or more of the characteristics indicated above (header only to some participants in the RTI, lack of mandatory clauses, etc.).

The presentation of the provisional guarantee issued by a person not entitled to issue the guarantee or not authorized to commit the guarantor can be remedied.

\* \* \*

- d) a copy of the power of attorney in the case of a statement made by a person with power of attorney whose name and powers are not reported at the Chamber of Commerce
- e) the **Bid declaration**, which, in accordance with the facsimile attached to this Request for Proposal, must specify the maximum overall contractual amount and all fixed and variable payments, which must not exceed the maximum amount of EUR 53.094. This must be submitted in electronic format, complete with the digital signature of the legal representative of the company, or, in any event, a party vested with proven power of attorney.

The competitor must also indicate in the economic offer (or it will be excluded from the offer) the "corporate costs of meeting the health and safety provisions" in the workplace referred to the art. 95, paragraph 10, of Legislative Decree no. 50/2016.

The documentation that constitutes the economic offer must be submitted in accordance with the provisions of Presidential Decree 642/1972 **on the payment of "stamp duty"**. The payment of the above mentioned duty has a value of Euro 16.00 and must be made by **Bank Transfer**, using the IBAN (International Bank Account Number) n° IT07Y0100003245348008120501 by specifying in Bank purpose of Transfer the following information:

"INFORMA GLOBAL MARKETS (EUROPE) LTD - VAT n. GB365462636 – Consip SpA P. IVA 05359681003- cod. trib. 456T – anno 2020 – RdA Consip n 49726".

As confirmation of the payment, the tenderer must send to Consip S.p.A. **a copy of the Bank Transfer receipt in PDF format**, within the deadline for submitting the offer.

- f) In the same mail, this company, if previously registered, will have to produce the document attesting the attribution of the **"PASSOE"** by the AVCPASS service. For this purpose, the supplier will be able to produce the Passoe in the form of a PDF document signed by the legal representative or subject with power of attorney.



- g) A **declaration** providing the identification details of the bank account (s) attached (s) to this contract, as well as the general (name and surname) and the Tax Code of the persons delegated to operate on said account (s) in compliance with the provisions of Article 3, paragraph 7 of Law No.136 / 2010 (**Supplier Data sheet and declaration on the traceability of financial flows**).

According to art. 83, paragraph 9 of Legislative Decree no. 50/2016, any formal deficiencies in the submission can be remedied through the “*soccorso istruttorio*” procedure.

In particular, in case of incompleteness and any other irregularities in the statements made, regarding the non-essential participation requirements (with the exception of those relating to the economic offer and the technical offer), Consip will give the operator a term not exceeding ten days, for the necessary declarations to be made, integrated or regularized, indicating the content and subjects that have to make the declaration.

If there are unjustified delays of the documents than the competitor will be excluded. Deficiencies that do not allow the identification of the content or the person responsible for it, constitute irremediable irregularities. Consip S.p.A., however, may require competitors to clarify the content of the documentation and statements submitted, that differ from the ones submitted that differ from those subject to a possible sanction within the meaning of the preceding paragraph, with the power to assign a peremptory term within which suppliers must submit the documentation required, **or they will be excluded** from the procedure.

A specific communication will be sent to the Supplier with the winning offer, which will require the successful tenderer to send to Consip S.p.A.:

- **within ten (10) solar days after the receipt of this communication**, the following documentation:
    - an appropriate document proving the provision of a **definitive guarantee**, in order to ensure the fulfillment of all the obligations agreed upon in the contract, the amount of which is in accordance with the discipline provided by art. 103 of Legislative Decree no. 50/2016.
- For the purposes of entering into the Contract, the successful tenderer must therefore pay, pursuant to art. 103 of Legislative Decree no. 50/2016, a definitive guarantee, in the form of a security or surety, equal to 10% of the contractual amount in favor of Sogei S.p.A./Administration. In the event of an award with discounts of more than ten per cent, the guarantee to be set up is increased by as many percentage points as those exceeding 10 per cent. Where the fall is greater than twenty percent, the increase is two percentage points for each bearish point greater than twenty percent.

Procedure in accordance with art. to art. 63, co. 2 lett. b), point n. 3 of Legislative Decree no. 50/2016, for the purposes of the conclusion of a contract for IGM ALL for Treasury Department.



The guarantee covers the fulfillment of all the obligations of the contract and the compensation for damages deriving from the possible breach of the obligations themselves, as well as the reimbursement of the sums paid more to the executor than the results of the final settlement, without prejudice, however, to the compensation of the greater damage to the contractor, any higher expenses incurred for the completion of the services in the event of termination of the contract ordered to the detriment of the executor, the payment of the amount due by the executor for the defaults deriving from the non-compliance with the rules and prescriptions of the contracts collective, laws and regulations on the protection, protection, insurance, assistance and physical safety of workers.

**The definitive guarantee must be issued in compliance with the standard guarantee guarantee contract schemes set out in Annexes "A" and "B" to the Decree of the Ministry of Productive Activities of 19 January 2018, no. 31, and in particular of the Scheme type 1.2 "Definitive guarantee" and the corresponding Technical Sheet.**

However, **a specific appendix** with which the Guarantor clarifies that:

- "Contracting authority" means: "la Sogei S.p.a. e Ministero Economica e Finanze";
  - art. 1 of the type 1.2 scheme. the lett. c) will be replaced as follows: "of any higher expenses incurred by the Customer for the completion of the works, services and supplies in the event of termination of the contract ordered to the detriment of the contractor".
- Consip has prepared a model that integrates the clarifications described above (Annex – Definitive guarantee facsimile) which it is suggested to use for the purposes of entering into the contract.

The guarantee, consisting of the two schemes referred to in Annexes A and B referred to in the aforementioned decree and the appendix, must also have **a notarized signature** and be irrevocable.

The guarantee must expressly provide for the waiver of the benefit of the prior enforcement of the principal debtor, the waiver of the exception referred to in art. 1957, second paragraph, of the Italian Civil Code, as well as the operation of the guarantee itself within fifteen days, upon simple written request from the Customer. The rules on reductions provided for by art. 93, paragraph 7, of Legislative Decree no. 50/2016. The successful tenderer will have to produce, if they have not been submitted in the tender, the documents / certificates certifying that they meet the requirements for the reduction.

Failure to establish the aforementioned guarantee determines the forfeiture of the award



and enforcement of the provisional guarantee and Consip S.p.A. may award the contract to the following competitor in the ranking. The guarantee ceases to have effect upon complete and exact execution of the obligations arising from the contract itself with the issue of the certificate of verification of conformity. If the amount of the guarantees decreases due to the application of penalties, or for any other reason, the successful tenderer will have to reinstate, as expressly provided for in the Contract, in the event of non-compliance, reinstatement takes place based on accrued income of price to be paid to the executor.

The guarantee is progressively released on the basis and according to the progress of the execution, up to a maximum of 80 percent of the initial guaranteed amount, according to the provisions of art. 103, paragraph 5, Legislative Decree no. 50/2016. In particular, the release will be carried out at quarterly periodicity, subject to the prior delivery, by the supplier to the Guarantor and the Principal, of a document, in original or authentic copy, certifying the regular execution of the contractual services, periodically issued by the Principal due to the conformity checks carried out. The Guarantor must communicate the value of the release to the Principal who can verify the correctness of the released amounts and ask the Supplier and the Guarantor in case of error for integration.

Please note that the services covered by the contract will be subject to payment of stamp duty, which the Supplier will be required to pay to Sogei when signing the contractual documentation.

The provisions of art. 35 of Italian Legislative Decree no. 90 of 24 June 2014, as converted by Law no. 114 of 11 August 2014, shall apply.

#### **DATA PROCESSING**

- the data provided by the winning bidder are acquired by Consip and transferred to the Client for the purposes of drafting and signing the Contract, for the fulfillment of the legal obligations connected to it, as well as for the management and economic and administrative execution of the contract itself.

#### **Nature of the conferment**

- communicated, subject to the conditions, to the Ministry of Economy and Finance or to another Public Administration for which Consip S.p.A. and the Client perform activities pursuant to the by-laws, with regard to the data provided by the winning bidder;
- communicated to other competitors who request access to the tender documents within the limits allowed under the law of 7 August 1990, n. 241;
- communicated to the National Anti-corruption Authority, in compliance with the provisions of the AVCP Determination n. 1 of 10/01/2008.

The name of the competitor awarded the tender and the contract award price may be disseminated via the websites **www.consip.it**, **www.acquistinretepa.it** and **www.mef.gov.it**. In addition, the information and data concerning the participation of the Competitor in the tender, within the limits and in application of the principles and provisions on public data and the re-use of public sector information (Legislative Decree 36/2006 and art. 52 and 68, paragraph 3, of Legislative Decree 82/2005 and subsequent amendments), may be used by the MEF and by Consip, each for its own responsibility, also in aggregate form, to be made available to other public administrations, natural and legal persons, including open data. In addition to the above, in compliance with the legal obligations that impose administrative transparency (Article 1, paragraph 16, letter b, and paragraph 32 of Law 190/2012, article 35 of Legislative Decree No. 33/2012; as well as Article 29 of Legislative Decree No. 50/2016), the competitor / contracting party acknowledges and agrees that the data and documentation required by law to publish, be published and disseminated, using the conditions, via the website **www.consip.it**, section "Transparent Company" and the website of the Client **www.sogei.it** for the activities of their respective competences.

In fulfillment of legal obligations, the data could be transferred to an international organization.

#### **Data retention period**

The data retention period is 10 years from the definitive awarding to the contracting authority and from the conclusion of the contract execution for the Customer>. Furthermore, the data may be kept, even in aggregate form, for study or statistical purposes in compliance with articles 89 of the EU Regulation and 110 bis of the Privacy Code.

#### **Automated decision-making process**

There is no automated decision making process.

#### **Rights of the interested party**



"Interested" means any natural person whose data are transferred from the competitor to the contracting authority and through it to the Customer.

The interested party is granted the rights referred to in Article 7 of the Privacy Code and referred to in articles. from 15 to 22 of the EU Regulation. In particular, the interested party has: i) the right to obtain, at any time, confirmation that personal data concerning him is being processed; ii) the right of access to personal data to know: the purpose of the processing, the category of data processed, the recipients or categories of recipients to whom the data are or will be communicated, the retention period of the same or the criteria used to determine this period; iii) the right to request, and in the case to obtain, the correction and, where possible, the cancellation or, again, the limitation of the treatment and, finally, can oppose, for legitimate reasons, to their treatment; iv) the right to data portability that will be applicable within the limits of art. 20 of the EU regulation.

If in the event of exercise of the right of access and related rights provided for by art. 7 of the Privacy Code or by the articles from 15 to 22 of the EU Regulation, the response to the request does not arrive within the indicated time and / or is not satisfactory, the interested party can assert his rights before the judicial authority or by contacting the Guarantor for the protection of personal data through specific complaint, appeal or report.
